1. Ellen Silverman, 10 N. Valley Road: Speaks about the resolution on the agenda regarding the Monmouth County Mosquito Control Division. Roosevelt is 1/3 in the wetlands and requires a special permit from the DEP for mosquito spraying and that should be added to the resolution.

The County would have to apply to the DEP, it's called a GP-15 permit. Attorney, Greg Cannon states the Borough either tells the County yes spray or no do not spray, it is the County's responsibility to get the permits. Discussion takes place on how and what the County is spraying. Ms. Silverman also states at the Environmental Commission meeting she is going to recommend that we do an educational campaign on standing water.

- 2. Mary Tulloss, 21 Lake Drive: Asks about Lake Drive re-paving and are curbs planned. M/Malkin states that half of Lake Drive was paved in 2005 and the other half in 2006 and the project probably will not happen until 2027, and as of now no decisions have been made.
- 3. Michael Ticktin, 37 N. Valley Road: Asks the name of the three nominations to replace Robert Atwood on Council. The names are: Katerina Paleckova, Ralph Warnick and Kristine Kaufman-Marut.

REPORTS OF COMMITTEE CHAIRS:

Environmental, Health & Safety: No Report.

Administration: C/Esakoff reports that he speaks with Ana Debevec every day. She is spending a lot of time on rental properties and sometimes she has to chase the owners for paperwork. There are 22 rental properties in the Borough. Fees can be increased and that could help pay a part-time person to deal with the rental properties. Attorney Greg Cannon states you can fine owner up to \$2,000 a day. Landlord registration needs to be enforced. Discussion takes place on the procedure for landlord registration and certificate of occupancy, code violations on rental properties. M/Malkin states we should discuss this at the next meeting.

Finance: No Report.

Community Dev/Code: C/Herrstrom asks if anyone has worked on quotes for the removal of the dangerous tree at the amphitheater? M/Malkin states we will have Ana Debevec contact tree removal companies for quotes. The construction plans for amphitheater are being worked on and should be ready by the 2nd meeting in March. The senior group will be going on a trip to the River Lady in Toms River on June 5th. Dues are \$15 annually and the trip will cost \$28.

Public Works: No report.

Utilities: C/Trammell reports that the generator at the sewer plant has a bad radiator and needs to be repaired. A new one will cost \$10,000-\$12,000. Oil pressure switch needs to be repaired which will cost about \$2,000. At the water plant new gravel will be installed and the driveway will be widened, the apron is already done. There is also an old slant road grader at the water plant which was used to clear roads from the inception. Greg was able to clean around it, so we may want to put it somewhere, it's an antique. It was used to plow roads back in the day.

REPORTS OF BOROUGH OFFICIALS:

- 1. Michael Ticktin, 37 N. Valley Road: I will be attending CDBG meeting online tomorrow.
- 2. Ellen Silverman, 10 N. Valley Road: The Environmental Commission meeting is tomorrow and will be discussing a possible rain garden at the school by the handball court area which will help with stormwater. Waiting to hear from the school. We applied for 800 plug native plants and 400 tree-

seedlings. We should know by next month if we get the plants. Discussion takes place on future sites for rain gardens.

OLD BUSINESS:

1. Improvements to Lake Drive and Spruce Lane: Council discusses how to move forward on improvements to Lake Drive and Spruce Lane. This was the project the Council had voted on to move forward with this project. The cost came in really high but Roberts Engineer said the project can be split in half which cuts the price in half. The Council discusses which half should be done first to utilize the NJDOT Municipal Aid grant received and then apply for another grant for the other half of the project. The Council discusses. M/Malkin suggests we do improvements to Lake Drive (South Valley Road to Spruce Lane) and Spruce Lane and C/Herrstrom is in agreement. C/Trammell would like to continue the discussion at the next meeting. C/Macher suggests to video the pipes for Lake Drive before we decided on what portion of the street should be done.
