REPORTS OF COMMITTEE CHAIRS:

Environmental, Health & Safety: No Report.

Administration: No Report.

Finance: C/Hamilton highlights the following: The CFO has emailed that he is currently working on the 2024 budget and may be available for a finance meeting the 3rd week of April. We received two

quotes for the tree removal at the amphitheater and both were \$2,800.00. He also forward to the school a copy of the tree report. You have a letter in your packets from Roberts Engineering on Lake Drive, regarding sewer lines, the water mains seem to be ok. There is also a letter from Roberts Engineering regarding N. Valley Road project, which is also no water mains needed.

The street tree inventory report list 140 hazardous trees, 42 require only minor pruning, 45 are at the lowest risk, which leaves 50 trees left. We need do a walk through to see which ones we can handle, develop a time line and assign dollar amount in the budget. Maybe this can be done over a three-year period with the Green Team helping. C/Trammell received an email that we can request Federal grants from Congressman Andy Kim for some of the work we need to do at the sewer treatment plant. The deadline is April 5, 2024. Mayor Malkin will call the Congressman but it will be impossible to meet the deadline of April 5, 2024.

Community Dev/Code: C/Herrstrom reports we are waiting for the school to sign off on the project. A lengthy discussion takes place regarding the grant agreement, the lease and who needs to sign off on the project once complete. Attorney, Greg Cannon will speak directly with Paul Gleitz. Numbers 10 & 11 in the agreement is what is in question. Attorney, Greg Cannon states at the April 15, 2024 meeting we will have a resolution executing the open space agreement and return the agreement to Monmouth County. We will continue to pursue the Board of Education for their authority.

The Senior Group meeting is tomorrow, April 2, 2024.

Public Works: No Report.

Utilities: C/Trammell reports that Ana provided him with a copy of the 2023 summary of the water/sewer report which is fundamentally doing well. North Valley Road were jet vac today. The beavers are back causing drainage problems on North Valley and Farm. The water plant yard stone project is complete, however, questions if the Borough should do the entire driveway, which may cost about \$5,000.00. He will speak to Ana to see if she can get quotes.

REPORTS OF BOROUGH OFFICIALS:

1. Environmental Commission Chair Ellen Silverman, 10 N. Valley Road: Arbor Day is April 26, 2024 and Mayor Malkin will be planting a Pitch Pine at the Pocket Park.

OLD BUSINESS:

1. Improvements to Lake Drive and Spruce Lane: C/Esakoff would like to see the whole road done and new piping for water and sewer, after we review the televised video. C/Trammell states we know North Valley is bad but will not know about Lake Drive until we review the video.

NEW BUSINESS:

 Sanitary Sewer Improvements to North Valley Road: The Council discusses the water problem on North Valley Road and now anticipates sewer improvements to be done. A Bond Ordinance for \$50,000 will be on the April 15, 2024 meeting for improvements to the sanitary sewer improvements.

GOOD AND WELFARE: C/Hamilton states:

- Bob Atwood sends his regards and is doing well.
- Today the lines were jet vac on North Valley and was glad we moved so quickly.

M/Malkin opens the public comment at 8:36pm.

1. Ellen Silverman, 10 North Valley Road: Our plans are to keep our trails looking good, we need to know how the water runs and would like a status on where the Borough Engineer is on the stormwater maps. This will be a great help.

M/Malkin closes the public comment at 8:41pm.
