Public Works: C/Macher states that Alan Tree Service took trees down over the weekend and asks if JCP&L tagged some unhealthy trees around town. M/Malkin informs him it is likely JCP&L.

Utilities: C/Trammell explains that the public meeting at the Wastewater plant went well and discusses some of the items that need to be repaired over the new few years. C/Trammell also thanks Ana for making and distributing the fliers for the public meeting.

REPORT OF BOROUGH OFFICIALS: Environmental Commission: Michael Ticktin explains that the Borough's portion of the grant that Ellen Silverman spoke about earlier is based on volunteer work.

UNFINISHED BUSINESS: C/Hamilton asks when the Certification of the Election results will be made available. Greg Cannon Esq. states the official results should be available Friday, November 19, 2021.

C/Hamilton asks when the new signs will be posted regarding the Borough's tree ordinance. Council discusses the issue and decides to have Ana look into pricing, location and language of the signs.

NEW BUSINESS:

- 1. Best Practice Inventory Report
 - M/Malkin announces that Roosevelt Borough has received a score of 21, which was the highest score Roosevelt Borough could receive because they do not qualify for the additional 4 points. Anything over 15 points, the Borough will receive full state aid.
- 2. Discussion regarding North Valley Road Drainage
 - The Council discusses the issue and the need to find out where the pipes are located based on the letter from Roberts Engineering, dated November 2, 2021. C/Esakoff objects to this work being done. The Council discusses. A resolution will be on the next council agenda authorizing Roberts Engineer to perform the field study along with a Certification of Funds.
- 3. C/Hamilton asks about the 2022 NJDOT municipal grant funding that Roosevelt received for the Improvements to Tamara Drive between Pine Drive and South Rochdale Avenue in the amount of \$173,700.00. He would like to know if the Borough would be able to do half of the road project and still receive the full grant amount. The Borough Attorney states that you can modify the project and still receive the full amount from NJDOT. The Council discusses the project length including replacing water/sewer mains. The Council will continue to discuss further until a decision is made.

PUBLIC COMMENT (Any item):

M/Malkin opened the meeting to Public Comment for any item at 8:21 pm.

Michael Ticktin, 37 N. Valley Rd. questions if the privately owned drains are an integral part of the drainage system for the road drainage then the Borough should require an easement. He also mentions that the Environmental Commission raised some issue regarding the tree ordinance in particular the enforcement of the ordinance and would like the Council to revisit the ordinance. The Council discusses and suggest possibly having an arborist on staff who would be able to determine the health of the tree in question or require tree companies to apply for the tree permit.

M/Malkin closed the meeting to Public Comment at 8:26 pm.
