Resolution Authorizing The Borough Engineer To Prepare A Field Survey, Base Map, And Evaluate The Existing Stormwater Collection System In The Area Of North Valley Road Between Homestead Lane And Farm Lane At A Cost Not To Exceed \$7,900.00

WHEREAS, the Borough of Roosevelt (the "Borough") maintains a stormwater collection system, a portion of which in the area of North Valley Road between Homestead Lane and Farm Lane is not properly operating at present; and

WHEREAS, the Borough Engineer has reviewed the issues with the stormwater collection system in the area of North Valley Road between Homestead Lane and Farm Lane, and prepared two preliminary options for possible remediation of the flooding issues in said area; and

WHEREAS, the Borough Engineer advises that a field survey and base map need to be prepared in order to fully evaluate the issues being encountered with the stormwater collection system in the area of North Valley Road between Homestead Lane and Farm Lane; and

WHEREAS, the Borough Engineer provided the Borough with a cost proposal not to exceed \$7,900.00 to prepare a field survey and base map and evaluate the Borough's stormwater collection system in the area of North Valley Road between Homestead Lane and Farm Lane;

WHEREAS, the Borough's Chief Financial Officer has certified the availability of funds in the amount not to exceed \$7,900.00;

NOW, THEREFORE BE IT RESOLVED, by the Governing Body of the Borough of Roosevelt, County of Monmouth, State of New Jersey that Roberts Engineering Group, LLC is hereby authorized to prepare a field survey and base map and evaluate the Borough's stormwater collection system in the area of North Valley Road between Homestead Lane and Farm Lane, in a total amount not to exceed \$7,900.00; and

BE IT FURTHER RESOLVED, that a certified copy of this resolution be sent to the Chief Financial Officer, Purchasing Agent, and Roberts Engineering Group, LLC.

C/Hamilton made a motion to adopt Resolution 21-133, with a second offered by C/Herrstrom.

C/Trammell explained that where it says Farm Lane it should read Between Homestead Lane and Farm Lane to encompass the entire drainage issue. C/Hamilton and C/Herrstrom amended their motion to include the change to read Between Homestead Lane and Farm Lane.
