C/Esakoff and C/Trammell would like the entire project to be done. C/Hamilton will set up a Finance Committee meeting and come up with a recommendation after the new year. C/Trammell stated that the utilities are looking good but we will need to invest in the future.

**UNFINISHED BUSINESS:** C/Hamilton brought up the issue of homeowners cutting down trees and asked what is being done. M/Malkin explained that signs have been ordered notifying the community about the tree ordinance. M/Malkin would also like to increase the fines and having an arborist on contract.
