REPORTS OF BOROUGH OFFICIALS:

Ellen Silverman, 10 N Valley Road: The Environmental Commission will be very busy this week, tomorrow we have our Dessert and Discussion; we are having a Rain Barrel Workshop, which will count for points towards the educational part of the Tier A permit. On Thursday, May 18, 2023, 2 environmental commission members and 1 green team member will be attending a stormwater map workshop given by Wetlands Institute. On Thursday evening, May 18, 2023, Ellen Silverman will be meeting with Kevin Scibilia, a Forrester, to discuss the tree inventory for Roosevelt.

UNFINISHED BUSINESS:

1. Monmouth County SCAT Program: M/Malkin states that it costs Roosevelt over \$8,000 a year for this service and only two residents use. We need to see if there is an alternative use or see if anyone else needs the service. C/Herrstrom also states this can be brought up at the next Senior meeting. C/Trammell makes a motion to table to the June 19, 2023 meeting; second by C/Herrstrom with an all in favor.

NEW BUSINESS:

1. Discussion regarding proposed Ordinances for Yard Waste, Wildlife & Salt Storage: M/Malkin states since we are missing 2 council members tonight maybe we should table until we have a full Council. C/Esakoff makes a motion to table to the June 19, 2023 meeting; second by C/Trammell with an all in favor.

PUBLIC COMMENT (Any item)

M/Malkin opens the public comment at 7:36pm

1. Jeb Shah, 18 Tamara Drive: Addresses a few concerns: 1- regarding elderly and disabled people living alone and are a danger to themselves and others around them. She has witnessed a terrible situation on her street. She contacted adult protection services and office on aging. We need to understand what is available to us by the office of aging and adult protective services in Monmouth County, maybe representatives can come to speak at a town meeting. What can they do, what can they not do and what advice can they give us? 2since plastic bags are no longer being used in supermarkets and other stores how do we recycling the items that are wrapped in plastic. ShopRite is not accepting the plastic and there is no place to recycle this. M/Malkin states maybe our Environmental Commission can research that. Ellen Silverman states that Home Depot recycles plastic bags and will check with ShopRite. 3- asks if someone is opening the deli? The borough needs a casual meeting place, besides the Post Office. Very important to physical and mental health. M/Malkin states that the Planning Board has not received any application. 4– Has the horse farm been sold? M/Malkin states we have not received any updated deed. Jeb Shah thinks it's important to get information to new residents about the town and how to get involved. M/Malkin states that we have a welcome packet that we give to all new residents.

M/Malkin closes the public comment at 7:51pm

M/Malkin states a couple is interested in buying the farm and want to put in a winery. They will grow grapes. They will retain many of the building on the property and they have no intention of hosting big events; simply wine tasting only. I would like the council to think about amending our ordinance and include wineries in our Agricultural Ordinance.

Attorney, Greg Cannon explains our RAG ordinance and discusses possible scenarios and changing ordinance and discussion took place regarding green acres frontage on Route 571 and Clarksburg Road.
