C/Trammell made a motion to adopt, with a second offered by C/Esakoff, to adopt the Consent Agenda Resolution's 23-85 through 23-89, by the following roll call vote:

Prior to the vote C/Trammell questions the payment for the installation of new water and sewer services at 19 S. Rochdale Ave; Municipal Clerk Kathleen Hart states that in the resolution it clearly states that the Borough requested and received escrow from the property owners to cover the costs. C/Trammell and C/Hamilton questions the payment to BIS Digital. C/Hamilton question why the Finance Department was not aware of this purchase. M/Malkin states that the previous recording system was of very poor quality, as you all know, throughout the meetings we heard knocking, all kinds of noises and it also was very difficult for our administrative staff to transcribe it. C/Hamilton states his question was about the process. M/Malkin states that C/Trammell was aware of the problems and he was looking into a new system that would cost approximately \$12,500 and Ana Debevec, Administration, contacted one of the companies that many towns use and the price was approximately \$900. It was a necessary expenditure. C/Hamilton states his question was about the process and we need protocols. M/Malkin states it was very transparent and the Council is aware of how poorly the current system was. C/Trammell states it was not transparent. M/Malkin states Ana Debevec in her position contacted other towns to see what they were using, she spoke with other

companies, found this system which has an excellent reputation, and spoke with people in other towns that use this system. M/Malkin and Ana Debevec discussed it and decided on this new system, which is a tiny fraction of the cost. C/Hamilton states it's the process and the Council should be consulted on expenditures of a certain dollar amount. C/Hamilton also questions the ETM payment.

Finance: C/Hamilton states he went to look at the storm drains during one of the torrential storms we had. They were clogged and need to be jet vac. We have a shared services agreement with the Monmouth County and maybe they can come out and look at the clog. M/Malkin states we will have Ana call and see when they can come out.

Community Dev/Code: C/Herrstrom states on August 1, 2023 we had our Roosevelt Senior Group meeting and discussed the making of sourdough bread. The next meeting will be September 5, 2023 and the project will be on the mapping of Roosevelt. We had about 15 people in attendance.

Public Works: C/Macher states the drainage pipes on County Roads need attention. We should ask the County about them too.

#### REPORTS OF BOROUGH OFFICIALS:

Ellen Silverman, 10 N Valley Road, states the Environmental Commission have voted on a mission statement and has a new sub-committee that is working on goals for the next couple of years. We have applied for Sustainable Jersey and have enough points for Bronze certification. We will be notified in September if accepted. If we could get part of the Stormwater mapping, especially in relationship to the channels that go across the trails, it will be very helpful in making our plans for the maintenance of the trails and keep those channels open so they don't flood. Benches were painted behind the head.

### **UNFINISHED BUSINESS:**

1. Draft Ordinance – An Ordinance Amending Chapter 2 "Administration", Article VII: "Administrative Fees", Subsection 2-59 Borough Hall Use: The Borough Council discussed. The word rental will be changed to use. Also, the ordinance now states that no alcohol is permitted within Borough Hall during any event. C/Hamilton states that as long as the application meets all requirements it does not need to go to the Borough Council for approval it can be done by Administration. Municipal Clerk, Kathleen Hart states that it states that applicant agrees not to attach anything to walls, doors, trim, ceiling, paintings unless approved in advance. C/Herrstrom states we don't want Ana Debevec to have to feel the weight of approving if there are any issues, how comfortable is she going to feel making the decision every time. Attorney Greg Canon states she can always send it back to the Council if she is not comfortable approving. C/Hamilton states under the heading "Right to use Borough Hall" there's a section that states form must be submitted at least 3 weeks before the event – since it's not subject to Council approval anymore, do we still need 3 weeks in advance notice. It is decided that that should be taken out.

2. Borough Attorney prepared a resolution to authorize the Borough Planner to review draft Ordinance 2023-07.

Resolution 23-90 Resolution Authorizing the Borough Planner to Review, Analyze, and Report Upon Borough Ordinance No. 2023-07 to Properly Include Vineyard and Winery Uses in the R-AG/400 Zone in an Amount Not to Exceed \$2,500.00 was read into the record.

WHEREAS, the Borough of Roosevelt, County of Monmouth, State of New Jersey (the "Borough"), seeks to preserve its rural character through development policies that promote agricultural uses and the preservation of open spaces; and

WHEREAS, the Borough faces significant threats of development on farmland and open space both within the Borough and surrounding its borders; and

WHEREAS, the Mayor & Council sought to update the Borough's development regulations and policies, and introduced Ordinance No. 2023-07 to promote more modern agricultural uses of land, and correspondingly, the preservation of farmland within the Borough;

WHEREAS, upon review of Ordinance No. 2023-07 by the Planning Board, significant issues were raised by the Planning Board and the Borough Planner regarding the proper implementation of such updated regulations; and

WHEREAS, the Borough seeks expert advice as to the appropriate implementation of the aforementioned land use goals, and has been provided with a proposal by the Borough Planner, Thomas Planning Associates, LLC, dated August 17, 2023, in an amount not to exceed \$2,500.00 to review, analyze, and provide a report with recommendations as to Ordinance No. 2023-07; and

WHEREAS, the Borough's Chief Financial Officer has certified the availability of funds in the amount not to exceed \$2,500.00.

NOW, THEREFORE BE IT RESOLVED, by the Governing Body of the Borough of Roosevelt, County of Monmouth, State of New Jersey that Thomas Planning Associates, LLC is hereby authorized to review, analyze, and provide a report with recommendations as to Ordinance No. 2023-07, in accordance with the Proposal attached hereto as Exhibit A, in a total amount not to exceed \$2,500.00.

BE IT FURTHER RESOLVED, that a certified copy of this resolution be sent to the Chief Financial Officer, Purchasing Agent, and Thomas Planning Associates, LLC.
