Environmental, Health & Safety: None

Administration: C/Esakoff states no report but commented that there were 39 cars backed up at the stop sign at the stop sign at Ely's Corner. They were mostly NY plates and probably leaving Great Adventure. M/Malkin states the other night on Rochdale there were no cars and all of a sudden there was a car doing about 70 miles an hour down Rochdale and believes it will only get worse once Adventure Crossing opens. A traffic study will have to be done eventually. M/Malkin states she wouldn't mind if we had guard rails along the school and post office property.

Finance: C/Hamilton reports that Safe Routes to School Grant, which consists of crosswalks, sidewalks, curbs on N. Rochdale may be a good idea to apply for. It also recommends a traffic study when applying for the grant. The school bike path from Pine/Tamara to the school is flooded very often and it would be easier if there were improvements there and maybe it can be part of the grant.

Community Dev/Code: C/Herrstrom reports today was the Roosevelt Senior Groups second meeting, with 21 seniors in attendance. They are working on mapping of the community which includes houses, starting with the original owners. Next meeting will take place on October 3, 2023. Our guest speaker will be a representative from Monmouth County Office on Aging. Currently there is no President but Ellen is the Vice President. C/Hamilton asks if it's possible to have a meeting at Solar Village? C/Herrstrom responds we can pick up anyone who is interested in attending from Solar Village and will hang a flyer at Solar Village. M/Malkin asks if C/Herrstrom knows when we might hear about the amphitheater grant? C/Herrstrom responds in October.

Public Works: C/Macher reports that DPW cleared fences around the water and sewer plants. There was a request to clear some poison ivy around the hydrants too.

NEW BUSINESS:

 Safe Routes to School – FY2024 NJDOT Application – M/Malkin asks if the Council wants to move forward with this and is upset we didn't receive the grant last year. Council agrees to move forward. The grant was designed for smaller towns, however, larger towns received the grant. C/Herrstrom asks if we should wait another year. M/Malkin states we have never received this grant and we have a school on a County road and the traffic has increased. With the proposed housing project going on in Millstone, we will also see an increase in traffic. M/Malkin asks if the kids on Tamara walk on Rochdale or do they walk down to the triangle, she wonders why the parameters are Farm and Homestead. The Council discusses how the kids walk to school and what roads they walk on. M/Malkin will discuss with Carmela Roberts if this area should be included.

Attorney, Greg Cannon reads the resolution in full:

Resolution 23-98 Resolution Authorizing The Borough Engineer To Make A Grant Application To The New Jersey Department Of Transportation's Safe Routes To School Grant Program For Curb, Sidewalk, And Crosswalk Improvements At Rochdale Avenue Between Farm Lane And Homestead Lane

WHEREAS, the New Jersey Department of Transportation ("NJDOT") announced that it is accepting applications for its Safe Routes to School grant program; and

WHEREAS, the Borough of Roosevelt (the "Borough") has previously benefitted from NJDOT grant programs; and

WHEREAS, under the process for the current NJDOT's Safe Routes to School grant program, the Borough would be required to submit a grant application, prepared by a professional engineer, on or before November 17, 2023; and

WHEREAS, the Borough Engineer recommends that the Borough make a grant application to the NJDOT for curb, sidewalk, and crosswalk improvements at Rochdale Avenue between Farm Lane and Homestead Lane; and

WHEREAS, the Borough Engineer provided the Borough with a cost proposal not to exceed \$5,000.00 to prepare and file a grant application with the NJDOT on behalf of the Borough.

NOW, THEREFORE BE IT RESOLVED, by the Governing Body of the Borough of Roosevelt, County of Monmouth, State of New Jersey that Roberts Engineering Group, LLC is hereby authorized to prepare and file a grant application with the NJDOT on behalf of the Borough to seek funding for curb, sidewalk, and crosswalk improvements at Rochdale Avenue between Farm Lane and Homestead Lane, in a total amount not to exceed \$5,000.

BE IT FURTHER RESOLVED, that a certified copy of this resolution be sent to the Chief Financial Officer, Purchasing Agent, and Roberts Engineering Group, LLC.
