Environmental, Health & Safety: No Report.

Community Dev/Code: C/Herrstrom gives an update on the amphitheater. Council committed \$660,000 to the project and the Borough received a grant from Monmouth County in the amount of \$330,000. Original project costs were \$826,554. At the November 9<sup>th</sup> the Council was asked to consider committing one half of the project cost which would be \$413,000 for a total project cost of \$743,000. The project committee met and came up with some cost savings. How much do we want to go out and bond for? C/Hamilton states the numbers we are working with have a contingency of 10%. C/Esakoff questions if the Borough can afford this; he does not think so. We have two million dollars coming for the trickling filters. We are going to have to tax people very heavily. M/Malkin does state for those who are not aware we are going to have a two-million-dollar project for the trickling filers to be replaced at the sewer plant. Also, with the new Stormwater regulations, which are mandatory from the NJDEP will be additional cost to the Borough. We will have to hire a full time public works employee. C/Herrstrom asks what kind of obligation do we have to the Fund for Roosevelt? Also with the County we were told not to put in an application if we were not going to come up with the other half of the costs. So how can this be questioned? C/Hamilton states that the

CFO estimated a cost to resident of about \$150 a year. We are very thankful that we got this grant. Discussion continues amongst council members regarding the amphitheater and its costs. Attorney, Greg Cannon states that usually design costs are included in the bond. C/Herrstrom states we should bond for the \$728,250. C/Esakoff disagrees, C/Macher agrees with the \$728,000 as does C/Hamilton. This dollar amount will be forward to CFO, George Lang to start the process for Bond Ordinance. Senior group's next meeting will be December 5, 2023 and it will be their Christmas Party. Let's get it posted on the website.

Public Works: C/Macher reports Monmouth County is vacuuming the storm drains.

PUBLIC COMMENT (Any item)

M/Malkin opens the public comment at 8:36p.m.

- 1. Tim Hartley, 29 Farm Lane Would like to talk about mandatory removal of hazardous trees on private property. He is a member of the Environmental Commission but is not here as a member, this has been spoken about at the Environmental Commission meeting. Mr. Hartley gives facts about hazardous and dead trees. The Borough has hired tree experts to do reports on borough hazardous trees. The Borough has ordinances on tree removal including the removal of bamboo trees. Recommendation dead trees of a certain size and in proximity of the right away or neighboring properties should be mandated to remove them. Should be added to Chapter 12 of the property maintenance code. M/Malkin asks Mr. Hartley which municipalities have these ordinance? Mr. Hartley states so far he knows of Jackson Twp., Highland Park, Manasquan and Princeton. C/Hamilton asks if then a homeowner who thinks their neighbor has a hazardous tree, would they contact code enforcement to report the hazardous tree? Mr. Hartley responds essentially that's how it would work. M/Malkin states this could be a hardship to homeowners. Tim Hartley doesn't feel it being a hardship is a reason not to do it. C/Hamilton also feels it should be a requirement, it's a matter of public safety and if it's dangerous.
- 2. Rainey Hartley, 29 Farm Tree Lane Discussed insurance requirements.
- 3. Michael Ticktin, 37 N. Valley Road This issue came up on his property on Tamara Drive and he took care of it. The property maintenance code says you have to maintain your property in a way that's not hazardous to anyone else.
- 4. Tom Curry, 3 Pine Drive States you should notify your neighbor and the other factor is the cost. Trees don't die overnight it's not something that happens right away it's something you can save for; it's a good ordinance. Thanks the council for moving forward with the bond ordinance for the amphitheater, yes it's a very good project for Roosevelt. Mr. Curry states that there are only three places where residents can gather in the town, Borough Hall, the School and the Amphitheater, it will be used more than just a couple times a year.
