### REPORTS OF COMMITTEE CHAIRS:

Administration: No Report.

Finance: No Report.

Community Dev/Code: C/Herrstrom reports the Amphitheater Committee had a table at the 4th of July picnic to inform the residents on the project. On June 19, 2023 there was presentation about the project, (the audio is posted on the Borough website). Also, there was a handout available regarding funding and the matching grant funds. The bond ordinance for the amphitheater would cost about \$72 per year for a house with an assessed value of \$300,000 and these numbers are estimates only. There was some discussion at the last meeting that Burt Ellentuck was not on board with this project. This past week the Amphitheater Committee had a zoom meeting with Burt Ellentuck to discuss any questions he had with the project in more detail. Mr. Ellentuck wanted them to describe what would happen with the drainage on this project. He also states that the Amphitheater was not maintained properly and that the right materials were not used when repairs were done over the years. He wanted details and was very pleased. C/Esakoff questions who will maintain the Amphitheater going forward? C/Herrstrom responds they are going to build it so water doesn't go in. M/Malkin asks C/Herrstrom is it true you can't go out to bid until the bond is passed and what happens if the cost comes in more than the bond? C/Herrstrom states they put in two contingencies. C/Kaufman-Marut asks questions about the entire project coming out, except the bust, and starting from scratch. C/Herrstrom states that you need to look at the civil engineer report and the bricks are going back in. M/Malkin asks is it true the County receives final approval on the project before moving forward. C/Herrstrom states yes, it's true. C/Herrstrom also states at the 4<sup>th</sup> of July picnic we had FDR quotations that will be selected and would like some be added to the base.

Environmental, Health & Safety: C/Kaufman-Marut reports she was asked if a stop sign could be added instead of a yield sign at the triangle (Tamara and Pine). The Council discussed and the Borough Attorney, Greg Cannon will research the Borough Code, Section 7.14 Stop Intersection for a Stop sign from Maple to Pine. Attorney, Greg Cannon states that a municipality may establish, by ordinance, a Stop sign.

Public Works: No Report. M/Malkin did report there was a water main break at Tamara on July 6, 2024 at 3am. The pipe had a big hole and was rusted through. The repair was completed.

Utilities: No Report.

C/Herrstrom reads letter of support for the Amphitheater from Jeb Shahn.

### REPORTS OF BOROUGH OFFICIALS: None

#### OLD BUSINESS:

1. Improvements to Lake Drive and Spruce Lane: M/Malkin states that the pipes were televised and we are awaiting Mr. Lyons report.

**NEW BUSINESS:** None

### GOOD AND WELFARE:

M/Malkin states that the goal as mayor is to preserve Roosevelt as much as possible, to stay true to its history, culture arts and a strong sense of community and family. M/Malkin states again she is in support rehabilitation to the FDR Memorial Amphitheater and not redesigning it to the scope and scale of the project.

### PUBLIC COMMENT: (Any item)

M/Malkin opens the public comment at 8:09 p.m.

1. Nona Sherak, 4 Maple Court: States that she noticed deep holes on Pine Drive and is concerned someone might get hurt. C/Macher states that it's a valve box and needs to be cleaned out, and cones

- should be placed around the holes. States that Jeb's letter was lovely, but getting free medical care is not going to help me pay the \$72. Jeb is concerned with someone getting hurt because something may break off but not concerned with someone burning their feet or falling on Blue Stone. Ms. Sherak asked to see a copy of the plans and wants to know where the Blue Stone is going.
- 2. Bob Atwood, 12 Pine Drive: States the Amphitheater needs to be totally restored and doesn't think that \$72, for each resident, is too much but he cannot speak for everyone. Blue Stone is questionable and maybe can be replaced with something else. He disagrees that the Memorial should be moved to the Amphitheater. Also comments that the white chairs in Borough Hall were purchased by RAP.
- 3. Jeff Klein, 21 Homestead Lane: States he is trying to understand the project and would like to see the grant details. Clerk, Kathleen Hart states he can send her an OPRA request for the grant application.
- 4. Bob Atwood, 12 Pine Drive: Questions if it is possible to change any of the material if you decided that the Blue Stone is not acceptable? C/Herrstrom states that yes you can change materials. M/Malkin closes the public comment at 8:31 p.m.

C/Esakoff states originally there was water at the Amphitheater and questions how do you clean it now?

C/Kaufman-Marut questions if the Amphitheater is going to look the same? C/Herrstrom states it is not going to look exactly the same.

C/Esakoff made a motion, with a second offered by C/Macher, to adjourn meeting with an All in Favor.
